State Street Global Advisors, Inc. has acquired **22.943% of the shareholding** of Groww AMC comprising **Equity Shares and Compulsory Convertible Preference Shares (CCPS)**. The **voting rights of State Street Global Advisors, Inc. are capped at 4.85% of the aggregate voting rights** of Groww AMC, in accordance with applicable regulatory approvals and conditions.
